These General Terms and Conditions are subject to change without notice, and comprise a legal agreement (License Agreement) between Carlo Gavazzi (the Author or the Licensor) and the person, company or other legal entity (the User or Licensee) who, by opening the envelope containing storage media, installing and/or using the Software, part of the Software, or merely visually observing its media contents, thereby confirms the User-Licensee's acknowledgement and complete acceptance of the License Agreement General Terms and Conditions.

By accepting and agreeing to the License, the User-Licensee likewise takes notice and acknowledges and agrees to all other documental, informative and explanatory materials, included with the software or made available in electronic form or online.

The Contracting Parties agree that this Agreement (License) is valid, with the equal force of a contract that was negotiated and signed by the Contracting Parties.

If you do not agree to be bound to the terms of this agreement, or if you are lacking authority to do so, you should not install or use the software, and you should return the Software in its original packaging within 10 days of purchase.

The User-Licensee may negotiate directly with Carlo Gavazzi Controls SPA a separate written agreement to complement or replace all and/or part of this contract.



1) Subject Matter of the Agreement

1.1) The purpose and legal purpose of this agreement is the utilization, for a consideration, of the Software "MAIA Cloud Connector Plugin Software" by the User-Licensee.

1.2) In accordance with the terms and conditions of this Agreement, Carlo Gavazzi Controls SpA (Author or Licensor) grants the end user (User or Licensee) a non-exclusive and non-transferable right (License) to use the Software "MAIA Cloud Connector Plugin Software". The software, documentation and materials relating to this License, on disk, read-only memory, or any other media or form, are licensed, not sold, in order to be used only under these limited license terms.

1.3) The rights granted through this agreement are limited only to Carlo Gavazzi Controls SpA's intellectual property rights for the Software "MAIA Cloud Connector Plugin Software" and do not include any other patents or intellectual property rights.

1.4) Carlo Gavazzi Controls SpA informs the user that, in general, no software can be developed to function without error as to all its possible applications and uses. In addition, updated versions of software may introduce new errors, which are not in previous versions. The User-Licensee agrees with the Author, and accepts that the Software may contain errors, and, as such, hereby he or she renounces all claims against the Author for such errors. Therefore, in his self-interest and in order to avoid damages to himself and / or others, the User-Licensee agrees to continually maintain and be responsible for, before, during and after each operation, accurate checks and controls, and to take accurate and detailed recordings, in order to rapidly discover and obviate possible Software malfunctions. The acceptance of the possibility that the Software may contain errors, the acceptance of the obligation to make all checks and inspections referred to in the preceding paragraph, and the acceptance of the fact that the author does not declare its software suitable for any particular purpose or effect, are conditions that must be met in order for the Author-Licensor to grant you the Software license.

1.5) As Licensee, the User is sole owner of any and all physical materials on which the Software was originally recorded. Thus, under this Agreement, the Author maintains the sole ownership of the physical materials and all otherwise classified rights within the Software. This License grants the User alone the right to use the Software in accordance with these Terms and Conditions, which is subject to further conditions and warnings that may be placed on the packaging, in the user manual, in the electronic documentation or in the online documentation of the product itself. All rights are reserved to the author or to other legitimate owners. This License does not include other service of support, maintenance, consultancy, staff training or any other kind of performance that is not expressly agreed to by the Author and by these Terms granted in writing.



2) Copyright

All rights and copyrights of the Software (including, but not limited to, images, photographs, animation, video, audio, music, text and other information attached in the Software), the accompanying printed materials and any Software copies, are property of Carlo Gavazzi Controls SpA. The Software is protected by copyright laws and international conventions. Pursuant to these copyright protections, the User must properly use the software as every other material covered by copyright, unless otherwise permitted by this License. The Software and all the authorized copies approved by Carlo Gavazzi Controls SpA are intellectual property, solely owned by Carlo Gavazzi Controls SpA. The Software structure, organization and code are valuable trade secrets and confidential information owned by Carlo Gavazzi Controls SpA. Except as expressly provided for in this contract. This Agreement does not grant the User any intellectual property right as to the Software; unless a right is expressly granted in this Agreement, it is reserved by Carlo Gavazzi Controls SpA.

2.1) Acknowledgment about third party software: some parts of the Software use or include software of third party or other material subject to copyright: Qt, QIron,Scythia.

3) Product Usage (Company License)

3.1) This License is intended for business use; the Licensee may install and use the Software on multiple computers and/or machines of the same company, under the conditions and terms of this License.

As such, this License allows the simultaneous coexistence of this software on more than one computer, and the Software may be made available on a network, to be used by multiple computers simultaneously.

The User can also make a backup copy of the program (only the original) or create a copy of the "backup" to be used only in the case the original copy is damaged. The materials, containing the backup copy together with any copies for business use, must be kept with diligence, in order to prevent the installation or use by any third parties, or transfer of the content in any way or form, to any third parties. As an express condition of this License, when producing a backup copy or any additional copies, you must reproduce, on the cover, every notice regarding the copyright, and any other rights or restriction indicated on the original copy, supplied by the Author.

3.2) If the Software is licensed for use as a new program version (Upgrade) or as a program update (Update), the new software may only be used to replace existing versions of the same software for which you previously possess a valid license. 3.3) The Software is considered a trade secret, and, therefore, cannot be fragmented, reverse-engineered or otherwise reduced in any manner perceptible to man or readable by computer devices. It is forbidden to modify, adapt, translate, sell, rent, lease, transfer, or tamper with the Software in any way.

In this case the Author is entitled to require that the User arrange for the return and/or destruction of all the Software copies, and all component parts in his possession, including documentation materials. The Author also reserves the right to seek damages from the User and to require the User take steps to remedy the situation. The Author will not, under any circumstances, be required to compensate the User.

4) Warranties and Liability

4.2) When repair is not possible, or not convenient, or when it is not possible to update the Software online, Carlo Gavazzi Controls SpA reserves the right to substitute, free of charge, the original Software with a new one, without any further liability to the User.

4.3) It is understood that Carlo Gavazzi Controls SpA does not assume any liability for Software defects that arise from the User's failure to duly follow the instructions for the Software contained in the Technical Documentation, the User's tampering, improper use or incorrect installation, configuration, maintenance, reparation, modification or alteration by either the User or by third parties.

6) Governing Law and Jurisdiction

6.1) This Agreement is governed by the laws of Italy. For any dispute concerning or arising under this Agreement, its enforcement or its interpretation, Italy shall have exclusive original jurisdiction.

6.2) The Author and User expressly declare to exclude the application of this Agreement in regards to the United Nations Convention on Contracts for the International Sale of Goods, adopted in Vienna on April 11, 1980, and subsequent modifications
